#### 8. FINANCE

- a) The 2021 accounts were now with the Independent Examiner.
- b) It was **AGREED** that there should be an additional debit card for the office to enable the ordering of stationery etc.
- c) The signatories had all been changed.
- d) The Wardens were updating the Financial Guidelines.
- e) Robert Culyer was coming to June PCC to talk about the Parish Giving Scheme.
- f) Donations via Good Box had increased.
- g) There had been several queries from people wanting to make card payments for bookstall items on Sunday mornings. This could be made possible and would be considered further.

#### 9. CLERGY WELLBEING COVENANT

It was **RESOLVED** to formally adopt the Covenant:

"The Church of England is part of the One, Holy, Catholic and Apostolic Church, worshipping the one true God, Father, Son and Holy Spirit. It professes the faith uniquely revealed in the Holy Scripture and set forth in the catholic creeds, which faith the Church is called upon to proclaim afresh in every generation In its formularies, the Church of England recognises that God calls some to serve as deacons, priests and bishops to build up and equip the whole People of God. Conscious that such a calling is both a privilege and a demand, we commit together to promote the welfare of our clergy and their households. We undertake to work together to coordinate and improve our approach to clergy care and wellbeing so that the whole Church may flourish in the service of the mission of God"

#### 10. THE VISION

a) The church family needed to own the Vision if it was to survive and thrive. The Vicar proposed holding 3 informal events to launch it – 13 March in the Parish Church, 20 March at St Martin's and an afternoon or evening session on 16 March.

b) The Vision documents would be available, including revisions suggested by Standing and Finance. The logo might not be ready by then, as there was to be a further meeting with the designer.

## 11. APCM TIMETABLE

- a) As well as the statutory reports, we should focus on areas that demonstrated new life, e.g., CCKids, Blokes Brekky, Youth Work, Women's Wellbeing Walk.
- b) The process began on 6 March when the notice of intended revision of the Electoral Roll was published. It was good to encourage new people to go on the Roll.

#### 12. SAFEGUARDING

The report was received. Alison Orsborne asked the Treasurer to investigate why payment hadn't gone through for a DBS check.

13. HEALTH AND SAFETY

David Anderson was thanked for repairing a floor tile in the Parish Church.
